Narrative

On December 31, 2013 at approximately 1831 hours, I responded to the 4th level parking garage for Maryland Live Casino located at 7002 Arundel Mills Circle, Hanover in reference to a child left unattended in a vehicle.

Upon arrival I spoke with Security Manager Renee Potee who stated a 4 year old child identified as Ailea Brown 4/3/09 was discovered inside a white GMC Terrain MD tag 1AY5147 by Security Officer Barbara Nixon. I then spoke with Barbara who was the first person on scene with the child, and who contacted the police. Barbara said she discovered Ailea alone in the GMC standing on the seat crying. Barbara asked Ailea if she was ok and Ailea said "no". Barbara then asked Ailea who she was with and Ailea said "her mom and she said she'd be right back when she left". Entry was made into the GMC and Ailea was placed in Maryland Live's Security vehicle to stay warm until Anne Arundel County Police and Fire Personnel arrived on scene. When Ailea exited the GMC she was in, Barbara and Renee said it was obvious she had urinated herself and was cold due to being wet. The outside air temperature at the time Ailea exited the vehicle was 34 degrees Fahrenheit 2 degrees above freezing. I then noticed blankets were placed covering the rear windows of the GMC so no one could see inside. Barbara and Renee said the GMC was observed entering the casino parking garage around 1000 hrs on 12/31/13 on security camera footage. Renee and Barbara said Ailea told them that she had arrived at the Mall with her mother only and there was no one else with them. Ailea was left unattended inside the GMC from approximately 1000

hrs until she was discovered by Security Officer Nixon at approximately 1831 hrs. There was no food or drink left for Ailea inside the vehicle or any means to stay warm due to the blankets covering the windows. The vehicle had not been running due to the hood being cold to the touch and the keys were not inside it. I then noticed the child car seat in the right rear of the vehicle was wet and smelled of urine.

After a while (approximately 30-40 minutes) Alicia Denice Brown arrived on scene and stated she was Ailea's mother. Alicia started to say where was her 17 year old cousin who was supposed to be there watching Ailea. Alicia then recanted her statement after I pointed out the fact that there were several security cameras in the garage saying she was there alone with Ailea. Alicia was then placed under arrest and transported to Southern District for Processing. Ailea was transported to BWMC for precautionary reasons by the Anne Arundel County Fire Department. Sgt. McBee followed the ambulance to the hospital remaining with Ailea until arrangements could be made for her.

I spoke with Alicia at Southern District asking her if she would like to speak to me or one of the Detectives regarding her side of the case and she replied "no". I contacted the Department of Social Services and spoke with Wendy McKenzie advising her of what happened to Ailea and put her in contact with Sgt. McBee at the hospital. I then contacted Sgt. White of the Criminal Investigation Division. Sgt. McBee then advised me that Wendy authorized the release of Ailea to the custody of her grandmother Alceson Ragland from the hospital. Alicia was charged accordingly and sent before the Commissioner where she was held on \$150,000 bond at the Jennifer Road Detention Facility.

Photographs were taken of the GMC and submitted with this report. A copy of this report was forwarded to CID and DSS. This case is closed with one adult arrest.
