Narrative

On 10/18/17 at 1119 hrs, Walter Paul Robinson Jr., DOB 07/19/94, called his sister, Nichole Robinson, by telephone. Nichole has known her brother her entire life and knows who he is when she speaks with him on the phone. Walter expressed to Nichole that he was "very agitated over a probation violation and was scared he will go to jail." Walter told Nichole that he will shoot Sheriff Ron Bateman, an elected local official, in the face and allow his wife, Elsie Bateman, to watch. Walter went on to add that he will "pistol-whip Elsie and then cut her up into pieces."

Walter told Nichole "It is very easy to shoot someone when [Sheriff Bateman] is walking out of his front door," and that he would "Rip Elsie's teeth out." Nichole said that "Walter believes that it is Ron and Elsie's fault he violated his probation and feels it is their fault if he goes to jail."

Walter "stated he had a gun... also stated he will get a Glock to take someone's life and he doesn't care because someone will die if he goes to jail." Nichole said that during her phone conversation with Walter he was very angry and screaming. Nichole took his threats very seriously.

In addition, Walter threatened Nichole and her family and anyone else who "got in his way" including the police. Walter stated to Nichole that if anyone calls the police and tries to get him locked up. He will just start killing everybody because he has nothing to lose. When he is finished killing who he can, he will take his own life.

The Anne Arundel County Police Department located Walter Robinson at the Arundel Mills Mall on 10-18-17.
