Dear Friends of Jessica Haire Campaign,

For more than 30 years, the communities surrounding the proposed Chesapeake Terrace Rubble Landfill have fought the Halle Development Company to prevent the construction of this landfill. If built, the landfill would destroy environmentally-sensitive areas immediately adjacent to residential communities, while damaging the quality of life throughout those communities.

Recently, we became aware of significant campaign contributions made by Halle Development Company, entities associated with Halle, and Halle family members and employees, to Jessica Haire. These contributions total \$251,900, or more than 40% of all contributions Haire has received in the last two reporting periods.
